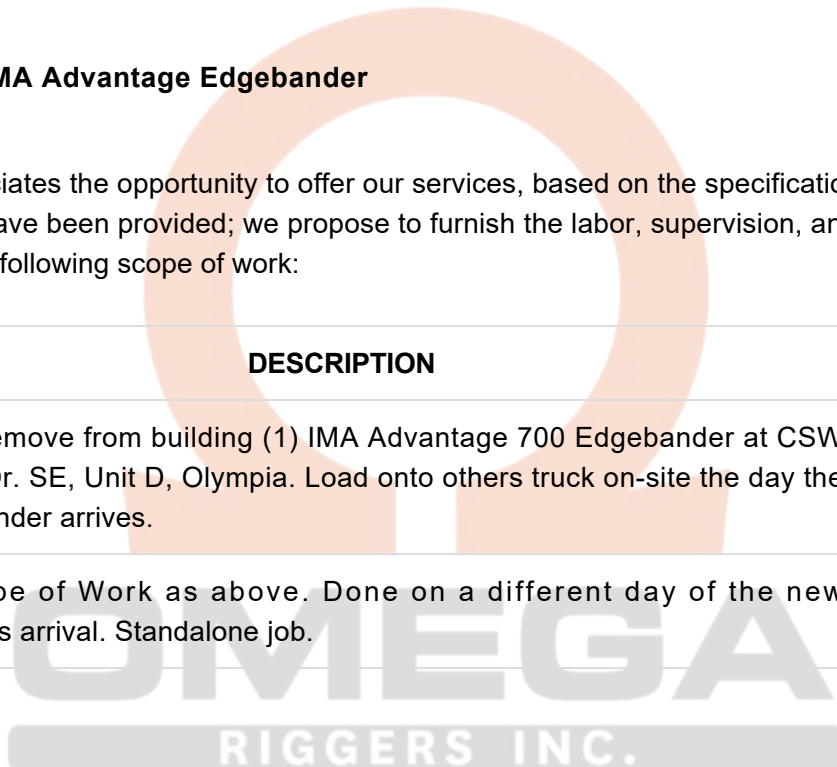

In the event that Contractor or sub contractors for Omega perform work outside the scope of work at the customer's request without a written change order, customer agrees to pay Contractor the agreed reasonable value thereof. Changes and Change orders are subject to project cost and delivery date modification in accordance with standard terms and conditions or as stated per terms of written change order.
